Instructions for candidates provisionally selected for admission to PhD programme - 2015-16

Candidates provisionally selected for admission to PhD programme at IARI during academic session 2015-16 may download their selection letter from July 10, 2015 and report **on July 31, 2015 at 9.30 A.M.** for registration at the IARI Central Library **along with the following documents:**

- Originals and attested copies of **i) Degrees, Certificates and Mark Sheets** of all the examinations starting from Matriculation onwards to the qualifying degree along with the certificate that your final viva voce examination has been conducted **ii) OBC/SC/ST/PC certificate** whichever is applicable. **OBC Candidates are required to furnish a valid OBC certificate (meant for Govt. of India posts) issued by the competent authority that they belong to OBC category and do not fall under creamy layer, in the calendar year 2015.**
- Proper relieving order along with the study leave / deputation order from your employer, in case if you are in employment.
- Candidates selected under 'Faculty Upgradation scheme' are required to submit duly filled in Annexure I of the Information Bulletin, failing which the admission shall be treated as cancelled.
- Medical Fitness Certificate from the Medical Officer Incharge of IARI Dispensary. For this formal letter will be provided by the P.G. School Office at the time of registration on **July 31, 2015.**
- The fee to be paid at the time of registration is ₹ 5900/=. The fee is to be deposited in Syndicate Bank, Pusa Campus, New Delhi-12, for which the PAY-IN-SLIP will be provided by the PG School office at the time of registration on **July 31, 2015.**
- Surety bond for a sum of ₹ 50,000/- on Non Judicial Stamp Paper amounting ₹ 100/- as per format given on IARI website as 'Instructions for candidates provisionally selected for Ph.D. admission'.
- Online submission of anti-ragging certificate as per guideline given on IARI website as 'Instructions for candidates provisionally selected for Ph.D. admission'

Enrolment Card shall be issued to you only **on fulfillment of all the requirements mentioned above.** You may be provided hostel accommodation in the Post Graduate Students' Hostel after the enrolment card is issued subjected to the availability.

The selection for admission shall stand cancelled in case you fail to report on July 31, 2015 at 9.30 A.M. and if you do not meet the eligibility requirements as given in the Information Bulletin.
