In case participants from ICAR/SAU's/KVK's/others are interested to attend the MTC, their TA/DA will be borne by the respective sponsoring organization/Institute. All participants are entitled for free boarding and lodging facilities during the training program. The selected candidates will be informed through e-mail/telephone so that they can make their travel program accordingly. Selection will be done on first-cum-serve basis.
