Terms and condition for the post of Field Assistant

- i. The post is purely temporary and will be filled on contractual basis till the termination of the project.
- ii. Maximum age for the post is 30 years (age relaxation of five years for SC/ST and women and three years for OBC). Minimum age should be 21 years as on date of interview.
- iii. The candidate shall not claim regular appointment at this institute, as the post is co- terminus with the project and committee’s decision will be final.
- iv. No TA/DA will be paid for attending the interview in person.
- v. Only the candidates meeting essential qualification would be interviewed.
