Advisory Circular

Corona virus cases rise unabated across the country. A massive rise in COVID-19 cases in Delhi is not seen even during the worst phases of the previous waves of Covid-19 in the Capital. IARI Authority has been taking all appropriate measures to control the spread of Covid-19 virus in the IARI campus. The Corona Monitor Cell of the IARI campus continues monitoring the current situation of IARI campus.

In view above fact and; In order to break chain of transmission of Corona virus and to prevent its further spread in the IARI Campus; it is decided that:-

1. All the officers/officials of ICAR-IARI, who are under isolation due to COVID-19, are instructed to avoid their physical attendance in the office/Labs or use of common facilities/areas; in order to prevent the further spread of COVID-19 at office as well as in campus.
2. In general, if there is a need to attend the office to perform the essential official work, all the concern officers/officials are instructed to take prior permission of concern HoD/ In-charge of Unit / controlling authority in this regard.
3. All the residents/students are advised to **use of double masks**, use of *Arogya Setu app* as well as **social distancing** & other COVID-19 protocol in the Campus whenever they go outside to purchase vegetables/milk or other essential items.
4. Security section is hereby instructed to keep watched out and compliance of above instructions & other preventive norms of COVID-19 in IARI campus. Further, Security officer may submit a list of those employees/residents/vendors, who are involved for non-compliance or don't cooperate for implementation of above instructions & other preventive norms of COVID-19 in IARI campus; to concern administrative authority for further necessary action.
