SUBJECT: ON LINE facility for ANTI RAGGING AFFIDAVITS to be submitted by each student.

As you know that each student must submit an Anti-Ragging Affidavit at the time of admission/registration in a College/University/Institute. Now, the UGC has decided that process of filling an affidavit should be simple where there would be no need for stamp paper and no need to get these affidavits signed by a Notary Public/Oath Commissioner. Students can go on line and download an affidavit.

Aman Satya Kachroo Trust (The trust works with UGC to manage and monitor the National Ragging Prevention Program since January 2012. The Trust has spearheaded the Anti Ragging Campaign since 2009) has created an ONLINE facility for creating the Anti Ragging Affidavits. In this facility, there is no money involved, no need to get affidavits signed by a Notary Public/Oath Commissioner and no need to get printed on a stamp paper etc.

The students are required to visit website of the trust **www.amanmovement.org.** For convenience, procedure is reproduced as follows:

- Step 1: Log on to www.antiragging.in OR www.amanmovement.org
- Step 2: Fill in the information as desired.
- Step 3: On successful completion you will receive affidavits, both for Students and Parents, through E-mail. Sign them and submit/send them to the Institute ONLINE through e-mail at (Pgs1.iari@icar.gov.in).
