Failure to deposit the Seat Acceptance Fee within the prescribed deadline shall be treated as non-acceptance of the allotted seat, and the provisional selection/allotment shall stand cancelled without any further notice. The vacant seat may thereafter be offered to the next eligible candidate as per merit and applicable category-wise reservation rules.

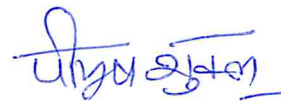
The provisionally selected candidates who have complied with the above requirements shall report at their respective allotted Institute, i.e. IARI Assam or IARI Jharkhand, for physical verification of documents on 24/09/2026 (Thursday) 10:00 AM onwards.

At the time of physical document verification, the candidates shall produce all the original documents and 02 sets of self- attested photo copies of required documents, 2 passport size photos, ICAR rank card, provisional admission letter, certificates and mark sheets of all the examinations starting from Matriculation onwards at the time of physical reporting to the IARI Assam and IARI Jharkhand campus respectively. Students selected against SC/ST/OBC/EWS/UPS etc. category should produce all certificates as per the Government of India guidelines. **If any candidate fails to provide/submit original certificates and/or additional documents, the provisional admission of the candidate will be cancelled and his/her claim for admission will stand forfeited.**

The provisional selection of a candidate shall be subject to successful verification of the original documents and fulfillment of all prescribed eligibility conditions. Mere inclusion of the candidate's name in the provisional selection list shall not confer any right to admission if the candidate is found ineligible or fails to produce the requisite documents at the time of verification.

If information furnished by the candidate is found to be incorrect or misrepresentation/concealment of facts at any time during the course of degree program, admission would be cancelled/forfeited and necessary action would be initiated against the candidate.
