

If any candidate fails to provide/submit original certificates and/or additional documents, the provisional admission of the candidate will be cancelled and his/her claim for admission will stand forfeited.
- All Ph.D. candidates are required to submit a surety bond (*please mention new roll no. issued by the Institute on the body of surety bond*) for a sum of Rs. 50,000/- (Rupees fifty thousand) (**Annexure-I**) and M.Sc. Candidate for a sum of Rs. 40,000/- (Rupees forty thousand) on non-judicial stamp paper amounting to Rs.100/- (**Annexure-II**).
- All the Newly admitted M.Sc. and Ph.D. Students are directed to Upload Anti-ragging Affidavits for themselves and for their parents/guardian and enter/fill his/her Anti-ragging Undertaking Reference Number in the column created in AMS Portal. If the students fail to comply with the above requirements, they will not be able to complete the registration process.
- All the provisionally selected candidates (M.Sc. & Ph.D.) to make sure that they fulfil all the eligibility criteria such as educational qualification, possess category certificate (as applicable)/PDC & Transcript. If any information is found incorrect at a later stage, admission would be cancelled forthwith.
- If at any time during the course of study programme, information furnished by the candidate is found to be incorrect or misrepresentation/concealment of facts, admission would be cancelled forthwith and necessary action would be initiated against the candidate.
