THE ITEMS SHALL BE SOLD TO THE BIDDER WHO WILL QUOTE THE CONSOLIDATED HIGHEST RATES. THE BIDS ARE INVITED FOR THE WHOLE LOT (i.e. ALL THE ITEMS CONTAINED IN THE LIST OF OBSOLETE ITEMS AS DETAILED AT **ANNEXURE-I** AS A WHOLE) AND NO BID WOULD BE ACCEPTED FOR ANY PART OF THE SAME.

Scope of Work:

Disposal of unserviceable & obsolete items, these items have been discarded and are no longer usable by this office.

Eligibility Criteria:

- 1. The bidder should deposit Rs.1700/- (Rupees One Thousand Seven Hundred only) as EMD in the form of an Account Payee Demand Draft (DD)/FDR/Banker's cheque/Bank Guarantee from a scheduled Bank in favour of the Director, ICAR-IARI, New Delhi- 110012. payable at New Delhi in a separate envelope and the same (in original) will be submitted in the Office of Division of Agricultural Extension Room No.02, Assistant Administrative Officer, Ag. Extension, ICAR-IARI, New Delhi-110012 before the cut-off date of submission of online Bid through GeM. EMD of the unsuccessful bidder shall be returned without interest at the earliest on finalization of the Auction.
- Copy of PAN No., GST No. & Aadhar/Address Proof, in the name of the proprietor/owner/firm/company is required to be uploaded on the GeM Portal. The document to be uploaded should be legible. In case the uploaded documents are not readable, the bid cannot be examined, and the bid can be rejected, thereby rejecting the bid of that firm.

Terms and conditions

- 1. The Unserviceable Material/items will be available on Auction "As is where is basis". The Unserviceable Material/items can be inspected by the interested parties on any working days between 10.00 Hrs to 16.00 hrs by contacting the Assistant Administrative Officer, Division of Agricultural Extension, ICAR- IARI, New Delhi-110012. No request for inspection after submission of the bid will be accepted.
- 2. The bid shall remain valid for 180 days after the date of bid opening. If any bidder withdraws his / her bid before the said period, this office shall without prejudice to any other right or remedy, be at liberty to forfeit the Bid Security absolutely. Conditional bid shall not be entertained.
- 3. Conditional bid shall not be entertained.
- 4. **Evaluation criteria**: The successful bidder will be the one which offers the highest total rate for the entire lot of scrap as detailed in **Annexure-1**, no part lifting of the items shall be allowed.
- 5. All the bidders shall fill the details of the EMD column on GeM Portal if the option is available before submission of bids.
- 6. The undersigned will not entertain any claim for damage done by the way of theft, fire or any other unforeseen calamity after realizing full payment against the Unserviceable Material/items.
- 7. The Unserviceable Material/ items is to be lifted up **within 10 days** on the issue of Release Order on making full payment in the form of an Account Payee Demand Draft (DD)/Banker's cheque **in favour of the Director, ICAR-IARI, New Delhi- 110012**. Otherwise, the EMD money deposited will stand forfeited and the offer shall be awarded to the next eligible bidder.
- 8. The successful bidder must lift all the Unserviceable Material/items at his own cost. If the party fails to lift the auctioned items within stipulated time or not make financial arrangement as per the schedule date, his EMD shall be forfeited, debarred from future tender/bidding and failing which the next bidder in line will be provided a chance, if only fulfilling our criteria. In case, the MSME bidder fails to do the above job, it shall also be debarred from future tender/ bidding process.
- 9. The bid without EMD (in original) will be liable for rejection.
- 10. The Institute does not guarantee to make any definite quantity and quality of articles available to the buyer.
- 11. The lifting of items must be done during working office hours. between 10 am to 4 pm not in the lunch hours i.e. 1:00 PM to 2:00 PM.

- 12. The lifting of the items shall be done without damaging the premises / roads / drains/ etc. The buyer shall compensate the damages, loss, etc., in the event of any occurrence otherwise.
- 13. **No selection or sorting whatsoever of the goods will be allowed.** The entire lot should be cleared by getting proper Gate Pass from ICAR-IARI, New Delhi-110012.
- 14. Any unclear or un-noticed materials left over by the successful bidder within the premises cannot be claimed later.
- 15. No enquiry of bidder shall be entertained once the material is lifted by them.
- 16. The materials being disposed of are to be treated in line with applicable rules/notifications/guidelines etc. as may be prescribed by the Government. The successful bidder shall be responsible to ensure this action.
- 17. At any time ICAR-IARI, New Delhi may modify the bidding document by amendment thereto. The amendment will be notified on the ICAR-IARI website only, which will be binding on bidders. Bidders should regularly visit the website https://iari.res.in to keep themselves updated.
- 18. Tenders not complying with the above conditions are liable to be rejected.
- 19. The Director, ICAR-ICAR-Indian Agricultural Research Institute, New Delhi-110012 reserves the right to accept or reject any or all the bids received without assigning any reason thereof.
- 20. All disputes including court proceedings shall be settled within the New Delhi Jurisdiction only.
