It should be ensured to make a <u>single PDF of duly filled application (Given in Annexure-I & II) along with self-attested copies of all certificates in a sequence while submitting to above mails, otherwise the applications are liable to be rejected.</u>
- 4. The eligible shortlisted candidates should report for the interview one hour before scheduled time on the date of interview for necessary formalities. Candidates appearing for interview

should bring two copies of their CV in prescribed application format given below (Annexure I & II), two passport size photographs and one set of self-attested photocopies of their certificates/mark-sheets/ experience proof etc. Applicants must bring with them original documents at the time of interview for verification.

- 5. Only the candidates having essential qualifications would be entertained for the interview.
- 6. No objection certificate from the employer, in case he/ she has an employment.
- 7. Candidates whose near/ distant relative(s) is an employee of the ICAR/ IARI, has to declare it and communicate this office as per format given below.
