Terms and conditions:

- 1. Age limit: Maximum age is 35 years for Junior Research Fellow (age relaxation of five years for SC/ST & women and three years for OBC). The minimum age should be 18 years as on date of interview.
- 2. The post is purely temporary and will be filled on a contractual basis for one year or till the termination of the project, whichever is earlier.
- **3**. The selected candidate shall not claim regular appointment at this Institute, as the post is co-terminus with the project.
- 4. The interview for eligible candidates will be held online, the details of which will be communicated to eligible candidates by email.
- 5. Reporting time for online interview will be communicated and all the candidates shall adhere to the instructions.
- 6. The candidates will have to compulsorily filled in application form (as per the format annexed), all the scan certificates from matriculation onwards, date of birth certificate, NET/equivalent certificate, degree certificate either original or provisional and a recent photograph enclosed onto the scan application form. Proof of experience and publications also need to be sent by email. The selected candidate will be required to produce all the original documents and medical

certificate at the time of joining. Proof of experience and publications also need to be submitted.

- 7. No TA/DA/ any other expenses will be paid for attending the interview.
- 8. Only the candidates meeting essential qualifications will be interviewed.
