1. The engagement will be purely on contractual basis, time bound, non-regular & co-terminus with the project and the incumbent shall not have any claim for regular appointment under ICAR or any further contractual engagement on termination of the project. The selected candidate shall have no legal right to claim regularization by absorption or otherwise or any further continued engagement on termination of the project.

2. The tenure of engagement will be initially for a period upto 12 months from the date of engagement or term of the project, whichever is earlier. The services of the incumbent shall stand terminated automatically on expiry of the period given in the offer letter.
