- 2. The position is purely temporary, time-bound and co-terminus with the project; the selected candidates shall not claim for regular appointments at IARI/ ICAR.
- 3. The salary is fixed in nature and candidate cannot claim for any increment and other government facilities. No HRA will be paid to the YPII.
- 4. The candidates will have to compulsorily bring the filled in application form (as per the format annexed)(Annexure 1), all the original certificates from matriculation onwards, date of birth certificate, NET/equivalent certificate, degree certificate either original or provisional and one set of the self-attested photocopies of all the required certificates from matriculation onwards and an attested/self-attested recent passport size photograph pasted on the application form. - 5. The YP-II will not be entitled for any regular leave, but are allowed to have CL and RH from time to time, not exceeding 10 days in a year. The YP-II are full time worker and are required to adhere to the administrative, financial and disciplinary regulations of ICAR-IARI, hence regular attendance of the YP-II will be maintained by keeping an attendance register.
- 6. The continuation of the selected candidate will depend upon the progress reviewed every six months by the Principal Investigator. However, his/ her appointment can be terminated any time by without prior notice period.
